Sir,

This is in continuation to our letter of even No. dated 9th June 2012 communicating the NPCC's approval in respect to the State's PIP 2011-12 and reference of State's letter No. T-21015/5/2012-NCD, dated 30th January 2012 and Letter No.113/ER/CS/NRHM-1 dated 7th September 2012, I am directed to convey the decision for two components on the subject mentioned above, as follows:-

1. **National Programme for Prevention and Control of Deafness (NPPCD):-** Against the proposed budget of Rs.60.73 lakhs for the year 2012-13, an amount of Rs.54.97 lakhs (Rs.54.47 Lakhs from the programme budget and Rs.0.50 Lakhs from NRHM Flexipool budget) is approved, details be seen at Annexure-I.
2. **Pay anomaly for Public Health Nurse for the year 2011-12 (FMR code- A.8.1.4):-** In the RoP 2011-12 approval was for Rs.18.48Lakhs for 14 PHNs, which works out to be 1 PHN @ Rs.11,000 per month. This year 2012-13, the approval of salary for PHN is @ Rs.14,000/- per month. So, there is no arrear in salary of PHNs.

This issues with the approval of AS & MD, NRHM.
