## **ORDERS BY THE GOVERNOR**

Imphal, the 18<sup>th</sup> May, 2021

<sup>c</sup> Whereas, the State Government has been taking numerous actions to prevent the spread of the COVID-19 infection in the State, by utilizing all the government resources at its command, with the cooperation of various Civil Society Organisations (CSOs) and Non Government Organisations (NGOs).

Whereas, the unabated increase in number of infections and active cases in the State indicates that more needs to be done with increased participation of the people and its representatives.

Now, therefore, the Governor of Manipur is pleased to constitute Village/Ward Level Task Force as detailed below:

#### I. Constitution.

- i. A Village/Ward/ Gram Sabha (whichever applicable) Level Task Force will be constituted with 6-10 members.
- ii. Villages in the remote areas with less than 150 houses should be clubbed together to form a Joint Task Force of about 200 households
  - The selection of the members and constitution of the Task Force will be notified by the
- Deputy Commissioner concerned after due consultation with the MLA of the constituency, reputed CSO/NGO active in the area and the local club(s).

## II. Assistance by Government.

- i. Task Force would be provided with PPE kit, sanitizers, masks etc. by the Health Department through the Deputy Commissioners/ Chief Medical Officers.
  - iii. Claims for the above amount are to be made through the Deputy Commissioner which will be sanctioned by the Relief and Disaster Management Department.

### III. Responsibilities, Dos and Don'ts.

- i. Ensuring that Covid Appropriate Behavior is followed by everyone, including whenever shops or vegetable vendors are allowed to open.
- ii. Ensure that persons in Home Isolation or Quarantine or in Micro Containment area do not come out of their houses.
- iii. Assist the government medical team in contact tracing and monitoring the health of those in Home Isolation.
- iv. Carrying out of IEC activities on various Standard Operating Procedures (SOP) and protocols adopted by the government and persuade the locals to adopt and abide by it.
- v. Movement/travel of persons on essential duties should be allowed while following Covid Appropriate Behavior, especially wearing of mask.
