ORDERS

Imphal, the 7th August, 2021

1. Whereas, the Chairperson, State Executive Committee of the State Disaster Management Authority in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 had issued orders extending the curfew imposed in the seven districts viz. Imphal West, Imphal East, Bishnupur, Thoubal, Kakching, Churachandpur and Chandel of the state for another four days while continuing to allow the activities permitted earlier vide orders No. H-1601/6/2020-HD-HD dated 03/08/2021. This order also lifted the day time curfew and imposed only night curfew and permitted a number of activities in respect of the remaining nine districts.
2. Whereas, there is a need to allow more economic activities in respect of the seven districts also while taking measures necessary for public health safety.
3. Therefore, in exercise of the powers conferred under Section 20(2)(a) of the Disaster Management Act, 2005 the undersigned in his capacity as Chairperson, State Executive Committee of the State Disaster Management Authority, hereby orders the following in respect of the entire State to be **in force for fifteen days w.e.f 08.08.2021 to 22.08.2021**:
 - i. Night curfew from 6 P.M. to 5 A.M. shall be enforced strictly.
 - ii. **The list of activities permitted in the state is at Annexure.**
 - iii. Unavoidable customary and religious rituals can be performed in open sheds by restricting the number of invitees to twenty only.
 - iv. Micro containment zones shall be strictly monitored by dedicated Police Department teams and Health Department teams.
 - v. Fresh cases of Covid-19 infections shall be isolated as soon as possible and brought to Covid Care Centres and Health Department shall arrange mobile medical team for regular health checks.
 - vi. Health Department shall scale up vaccination, contact tracing and testing by providing additional manpower, mobility support and IEC-Advocacy.
4. Deputy Commissioners shall issue necessary orders and Superintendents of Police shall take necessary action to implement the orders strictly.
5. High Court may issue orders in respect of Judicial Courts

A. Government offices, PSUs and other public utilities.

- i. All Secretariat Departments and Manipur Government Directorate offices and offices of the Government of India to start functioning with e-office and physical attendance of Group A officers and 33% of the remaining staff from 09/08/2021 by taking adequate precaution and strictly following Covid Appropriate Behaviour.
- ii. All employees and personal staff working in Information and Public Relations, Power, Fire Service, PHED, CAF&PD, Home, Health, Relief & DM, Forest, Environment & Climate Change, Finance and Treasuries and Police departments and District Administration to function normally.
- iii. Imphal airport shall remain open and movement of staff and passengers will continue to be permitted.
- iv. Offices of Insurance Companies with limited staff on Monday, Wednesday and Friday from 10.00 AM to 2:30 PM.
- v. Postal services with limited staff on Monday, Wednesday and Friday from 10.00 AM to 2:30 PM including delivery of medicines, medical equipment and posts. Limited number of officers and staff can function on the remaining days without public transaction.
- vi. Banking services with limited staff on Monday, Wednesday and Friday from 10.00 AM to 2:30 PM for urgent Government and non-government transactions only. Limited number of officers and staff can function on the remaining days without public transaction.
- vii. ATM services including refilling of cash in ATMs are allowed.

B. Health and Welfare Services.


- i. Opening of all healthcare facilities, including animal healthcare, hospitals, clinics, nursing homes and movement of healthcare workers.
- ii. Opening of all pharmacies, including those selling veterinary medicines.
- iii. Opening of Opticians outside Thangal Bazaar and Paona Bazaar from 10 AM to 2 PM.
- iv. Movement of persons going for COVID-19 vaccination, COVID testing and medical emergencies.
- v. Child Protection Services (Orphanages, Children Homes, Observation Homes, etc).
- vi. Home delivery services under ICDS/ICPS (supplementary nutrition for children, pregnant & lactating mothers).

C. Agricultural and Horticultural activities.

- i. All agricultural and Horticultural activities.
- ii. Opening of shops and establishments dealing with inputs like fertilizer, seeds, pesticides, mechanical tools, fish feed and animal feed.

D. Shops and Establishments.

- i. Opening of Rice mills and Bakeries subject to taking adequate precaution and strictly following Covid Appropriate Behaviour.
- ii. Opening of Petrol pumps and LPG outlets and movement of staff of IOCL will continue to be permitted.
- iii. Opening of spare parts shops – one each out of three spare parts shops, three tyre shops and three battery shops of heavy vehicles in Thangal Bazaar is allowed to open 10 AM to 2 PM on all days except Sunday. Roster in this regard to be prepared by the DC and SP/IW. Authorized dealers of spare parts, tyre and batteries of heavy vehicles located outside Thangal Bazaar may also be allowed to open from 10 AM to

2 PM. This permission is subject to taking adequate precaution and strictly following Covid Appropriate Behaviour.


- iv. Opening of workshops - Vehicle workshops of goods trucks, Petrol tankers, LPG bullets etc. may open from 9 am to 3 pm on all days taking adequate precaution and strictly following Covid Appropriate Behaviour.
- v. Opening of stationery shops and authorized service centres of mobiles and personal computers from 10 AM to 2 PM on Monday, Wednesday and Friday.
- vi. Opening of local vegetable vendors from 7 am to 10 am for purchase by the locals on Sunday, Wednesday and Friday. The vegetable vendors should be seated at least 6 feet away from one another on spaces marked by District Administration and should wear mask all the time.
- vii. Only one out of three grocery shops of the total shops/vendors in one location shall be allowed to open on rotational basis from 7 am to 10. Shops selling fish, poultry and poultry products from 8 AM to 11 AM on Monday, Thursday and Saturday. Shops selling milk and fresh milk products every day from 6 AM to 9 AM.
- viii. Whole sale shops of grocery and food essentials located in Thangal Bazaar and Masjid Road will be allowed to open from 7am to 1200 noon as per schedule below:
