## **ORDERS BY THE GOVERNOR OF MANIPUR**

Imphal, the 26<sup>th</sup> May, 2021

No.MED-1706/10/2020-HS-HEALTH: Whereas, COVID-19 has been declared a global pandemic by the World Health Organization and declared as a notified Disaster by the Government of India;

- 2. Whereas, under Section 2 (a)(iii) of the Manipur Essential Services Maintenance Act, 2010, Essential Services is defined as "any services connected with the maintenance of public health and sanitation, including hospitals, dispensaries, Primary Health Centres and Primary Health Sub Centres";
- 3. Whereas, Section 2 of the Epidemic Diseases Act, 1897 provides the State Government with power to take special measures and prescribe regulations as to dangerous epidemic disease;
- 4. Whereas, under the following relevant Sections of the Disaster Management Act 2005, the State Executive Committee may;-

**Under Section 22 (2) (h)-** give directions to any Department of the Government of the Government of the State or any other authority or body in the State regarding actions to be taken in response to any threatening disaster situation or disaster.

## **Under Section 24-**

- (d) provide shelter, food, drinking water, essential provisions, healthcare and services in accordance with the standards laid down by the National Authority and State Authority".
- (e) give direction to the concerned Department of the Government of the State, any District Authority or other authority, within the local limits of the State to take such measures or steps for rescue, evacuation or providing immediate relief saving lives or property as may be necessary in its opinion."
- (f) require any department of the Government of the State or any other body or authority or person in charge of any relevant resources to make available the resources for the purposes of emergency response, rescue and relief;
- (h) procure exclusive or preferential use of amenities from any authority or person as and when required;
- (j) ensure that non-governmental organisations carry out their activities in an equitable and non-discriminatory manner;

5. Now therefore, with a view to ensure that reasonable rates are charged by private hospitals for COVID-19 treatment, the Governor of Manipur is pleased to order that the upper limit of charges for Covid treatment shall be as follows:

| SL No. | Category of bed            | Maximum charges per day (in Rs.) |
|--------|----------------------------|----------------------------------|
| 1      | General/Isolation          |                                  |
|        | i. Without O2 support      | 3,000/-                          |
|        | ii. With O2 support        | 5,000/-                          |
| 2      | High Dependency Unit (HDU) | 7,000/-                          |
| 3      | ICU without ventilator use | 8,000/-                          |
| 4      | ICU with ventilator use    | 10,000/-                         |

- 6. The per day charges above includes the following:
  - i. Registration charge
  - ii. Bed charge
  - iii. Nursing and boarding charge
  - iv. Medicine and Drugs
  - v. Oxygen charges
  - vi. Pathology and Radiology test
- 7. High end medicines like Remdesivir can be charged separately at the rate of **Rs.3,400/-** per dose (i.e. the current GoI prescribed rate). PPE costs maybe charged separately based on actual use and the cost should be sub-allocated among patients based on rounds taken by the doctors/nurses.
- 7. It is clarified here that PMJAY and CMHT beneficiaries are covered for COVID-19 hospitalization expenses. Their bills will be processed as per PMJAY/CMHT norms and procedures.
- 8. This issues with approval of the Competent Authority.
