OFFICE MEMORANDUM

Home Isolation is an important component in handling Covid-19 pandemic. With a view to streamline the monitoring & care of Home Isolation cases, the SoP are revised as follows:

A. Key tasks of the State Home Isolation Team would be as follows:

- i. Ensure line listing of fresh Home Isolation cases is compiled on daily basis by districts and sent to State HI Team.
- ii. State HI Team to compile the District line lists and Tele callers of State HI Team to start telemonitoring immediately.
- iii. State Tele Callers to record status of patients, including Comorbid conditions (if any).
- iv. State HI Team shall share list of fresh Home Isolation cases every evening to the Assembly Segment Covid Committee by email/whatsapp.
- v. State HI Team shall ensure that the District HI Teams distribute the drugs and pulse oximeter to all Home Isolation cases. When there are more than one positive case in a family, pulse oximeter will be limited to one.
 - B. To strengthen the health monitoring & care of the persons on Home Isolation, the following arrangements are put in place:

(i) Medical Helpline:

- a. Medical officers on Telemonitoring Duty to undertake telephonic assessment to patients who have complained regarding developing symptoms of breathlessness, SpO2 >94% etc.
- b. He/she should give necessary medical advice and follow up on 2-4 hourly basis till condition improved/patient admitted.
- c. If admission is required, necessary coordination with suitable CCCs/Hospital should be done as soon as possible.

(ii) Specialist Helpline by linkage with State Treatment Protocol Team

- a. In case of need of specialist or expert consultation, the Medical officers on duty shall consult with the <u>State Covid Treatment Resource Group</u>.
- b. The State Covid Treatment Resource Group will consist of Dr. N. Hemantakumar, SNO (Treatment Protocol) and specialists from JNIMS/RIMS.
