SUBJECT: GUIDELINES TO BE FOLLOWED FOR ADMISSION OF COVID-19 POSITIVE PATIENTS IN ILAND COVID CARE CENTRE, CANCHIPUR AND CATHOLIC MEDICAL CENTRE (CMC), KOIRENGEI

- The State Covid-19 Admission Committee (SCAC) shall be overall responsible for management of admissions of Covid-19 positive cases in ILAND Covid Care Centre, Canchipur and Catholic Medical Centre (CMC), Koirengei. It shall be assisted by the concerned District Covid Admission Committee (DCAC).
- Referral of patients under home isolation shall be made by the District Home Isolation teams to the CMO/District Covid Admission Committee (DCAC). The same shall be verified and forwarded by the CMO/District Covid Admission Committee (DCAC) to the State Covid-19 Admission Committee (SCAC) for issue of authority letter for admission to the concerned Hospital.
- 3. Referral of patients from Covid Care Centers (CCC) within Imphal East and Imphal West shall be made directly by the Medical Superintendent/Medical Officer (MO) incharge of the concerned Covid Care Centres to the State Covid-19 Admission Committee (SCAC) for issue of authority letter for admission to the concerned Hospital.
- 4. For other Covid Care Centers (CCC) referral will be made through the concerned CMO/District Covid Admission Committee (DCAC).
- 5. Referral of patients from District Hospitals/Sub-District Hospitals/Community Health Centers etc. will be done by the CMO/District Covid Admission Committee (DCAC) to the State Covid-19 Admission Committee (SCAC).
- 6. The authorities of ILAND COVID CARE CENTRE, CANCHIPUR AND CATHOLIC MEDICAL CENTRE, KOIRENGEI shall constitute an admission committee which shall coordinate directly with the State Covid-19 Admission Committee (SCAC).
- 7. ILAND COVID CARE CENTRE, CANCHIPUR AND CATHOLIC MEDICAL CENTRE, KOIRENGEI shall follow the admission and discharge criteria as prescribed the State Level Technical Expert Committee from time to time.
